- b. The institution shall maintain the teaching staff strength of 1+5 for the proposed STC Course.
- c. The institution shall adhere to all the other regulations and guidelines as framed by NCTE from time to time.
- d. The institution shall within one month of the receipt of Recognition order, convert the Endowment Fund account into a Joint Account in the form of FDR for a period of not less than 60 months (Five Years) in a Nationalized Bank only to be operated alongwith an official of the Regional Committee.
- e. That the Reserve Fund for an amount of Rs. Three Lakhs be maintained in the form of FDR in favour of the management / institution.
- f. Further, the recognition is subject to fulfillment of all such other requirements as may be prescribed by other regulatory bodies like UGC and State Government etc.
- g. The institution shall submit the Regional Committee a Self-Appraisal Report at the end of each academic year alongwith a copy of approval of the affiliating University / State Directorate of Education about the appointment of faculty members and the Statement of Annual Accounts duly audited by a Chartered Accountant.
- h. The institution shall regularly update its website.

If the institution contravenes any of the above conditions or any of the provisions of the NCTE Act, Rules, Regulations and / or order made or issued there under, the Regional Committee may withdraw the recognition under the provisions of Section 17(1) of the NCTE Act, 1993. The NCTE Hqrs. May also cause inspection under Section 13 of the NCTE Act, 1993.
